- Article 1 Thin Film Technology Center (hereafter referred to as "the Center") of the College of Science was established in accordance with the National Central University Regulations on the Establishment of Functional Research Center. The Center aims to promote thin film technology, combine the manpower and resources of various domestic and foreign research institutions, train thin film technology talents, promote industry cooperation projects, and integrate cross-field basic research and engineering application.
- Article 2 The Center is responsible for promoting research, teaching, and services related to thin film technology. This includes project research, talent training, policy guidance, industry collaboration, international cooperation, and organizing seminars.
- Article 3 The Center Committee is established. Committee members are faculty or researchers participated in the Center's project. The Director is nominated by committee members and the appointment is submitted to the Dean for approval. The Director is in charge of the Center with a term of three years and may be elected for consecutive term.
- Article 4 The Center meetings can be proposed to convene by either the Director or a committee member. The Director is to be the chair-person. In the event that the Director is unable to attend, one committee member may be delegated to be the chair-person.
- Article 5 The Center may establish an Advisory Committee, Committee members include scholars and experts from both inside and outside the university

appointed by the Dean. The committee provides guidance and advice on the direction and operation of the Center.

- Article 6 The Center may hire researchers, technicians, and assistants as needed. The required faculty is to be allocated from the total staff quota of the university.
- Article 7 The appointment, dismissal, and promotion of researchers and technical staff in the center are handled by the Center Meeting in accordance with the relevant regulations of the university.
- Article 8 The Center may establish laboratories to conduct relevant research and testing services, providing consultation, training, and testing services externally. The Center may also accept commissioned research and collaborate on research projects, and establish industry-academia alliances, utilizing a membership-based approach to serve external partners. All project undertakings shall be conducted in accordance with the relevant regulations of the university."
- Article 9 The center operates on a self-sufficiency principle for its required funds. In addition to seeking subsidies from the school and relevant units, it may also accept commissioned research and sponsorship. Income and management of the fund is conducted in accordance with relevant regulations.

Article 11 This regulation is approved by College Affairs Meeting and examined by Functional Research Center Committee. Revisions shall follow the same procedure.
